

Privacy Policy

This is the privacy policy of Edulution entities, comprising entities registered in Switzerland, Namibia, Zambia and South Africa, whether part of a group of companies and or whether using the Edulution name by virtue of having concluded a license agreement with Edulution Holdings SA (referred to as (Edulution entities)¹. In this document, "we", "our", or "us" refer to Edulution.

Introduction

This privacy notice aims to inform you about how we collect and process any information that we collect from you, or that you provide to us. It covers information that could identify you ("personal information") and information that could not. In the context of the law and this notice, "process" means collect, store, transfer, use or otherwise act on information. It tells you about your privacy rights and how the law protects you.

We are committed to protecting your privacy and the confidentiality of your personal information. Our policy is not just an exercise in complying with the law, but a continuation of our respect for you and your personal information. We undertake to preserve the confidentiality of all information you provide to us and hope that you reciprocate.

Our policy complies with the Protection of Personal Information Act 2013.

The law requires us to tell you about your rights and our obligations to you in regard to the processing and control of your personal information. Except as set out below, we do not share, sell, or disclose to a third party, any information collected through our website or via email.

This Privacy Policy applies only to information we collect through the Website and does not apply to our collection of information from other sources. This Privacy Policy, together with the Terms and conditions posted on our Website, set forth the general rules and policies governing your use of our Website. Depending on your activities when visiting our Website, you may be required to agree to additional terms and conditions.

Cookies

Edulution does not use cookies on its website.

Privacy Policy Changes

Although most changes are likely to be minor, Edulution may change its Privacy Policy from time to time, and in Edulution's sole discretion. Edulution encourages visitors to frequently check this page for any changes to its Privacy Policy. Website Visitors

¹ It should be noted that due to the fact that Edulution entities operate in a number of jurisdictions, the entities are subject to different legislation and regulations. Notably in South Africa, the Edulution entity is subject to the Protection of Personal Information Act 2013, the provisions and requirements of which this Information Impact Assessment document has incorporated and taken cognizance of.

Like most website operators, Edulution collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Edulution's purpose in collecting non-personally identifying information is to better understand how Edulution's visitors use its website. Gathering of Personally-Identifying Information

For example, we ask visitors who sign up for a blog at <https://edulution.org/> to provide a username and email address.

While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.

Protection of Certain Personally-Identifying Information

Edulution takes all measures reasonably necessary to protect against unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

Aggregated Statistics

Edulution may collect statistics about the behavior of visitors to its website. Edulution may display this information publicly or provide it to others. However, Edulution does not disclose your personally-identifying information.
